

YMCA 'Active August' PROMOTION - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

(1) This 'Active August' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).

(2) By participating in the Promotion, you agree to be bound by these Terms.

(3) The Promotion is available at Macleod Recreation & Fitness Centre (**Participating Centre**) between the dates of **1 August 2026** and **31 August 2026** (**Promotion Period**).

(4) To be eligible for the Promotion:

- a. you must be an existing member at the relevant Participating Centre; and
- b. you must register for the Active August challenge through the Technogym app and log at least 8 workouts and/or group fitness classes in the Technogym app during the Promotion Period.

For the avoidance of doubt, only workouts and/or group fitness classes logged in the Technogym app during the Promotion Period will count toward this Promotion.

(5) The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

2. SIGN UP TERMS

(1) If you meet the criteria set out in clauses 1(4) and 1(5) above, we will award you a minor prize, being your choice of a free Reformer session, Sauna session or Recovery session, and you will also receive one (1) entry into the draw to win the major prize.

(2) Participants who complete a health club appointment during the Promotion Period will receive one (1) additional entry into the major prize draw for each eligible health club appointment completed, provided they have first completed the required 8 workouts and/or group fitness classes logged in the Technogym app.

(3) Eligible health club appointments include Planning Sessions, Check-ins, Reviews and Bio-Scans.

(4) The minor prize is limited to one (1) prize per eligible participant.

(5) The major prize is one (1) month of Gold membership plus three (3) x 30-minute personal training sessions. There will be one (1) major prize winner.

(5) Members will be bound by their terms of membership with YMCA. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
